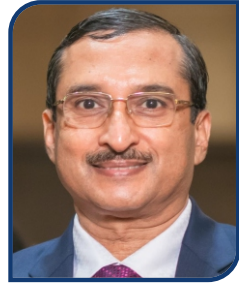

Draft Minutes of the GB Meeting - UAUCON 2022

Draft Minutes of the GB meeting

held on 26th March 2022 at Hotel Radisson Blu, Gorakhpur

Dr Neeraj Agarwal, President UAU started the meeting. He requested that only the UAU members to be present in the meeting. He welcomed the members present in the GB and requested for support and a fruitful participation.

He then handed over to Dr Vijay Bora, Hon Secretary, UAU to take over the meeting.

Roll Call

Dr Vijay Bora requested all the members to sign the register for the roll call.

Approval of Minutes of GB meeting at Agra

He informed that the minutes of the last GB meeting at Agra were circulated well in time and requested the members to pass the same. Members approved.

Proposed by Dr Sameer Trivedi and seconded by Dr H S Pahwa.

Hon Secretary Report

Dr Vijay Bora presented the secretary report. He thanked all the members for having him as the secretary for the past 2 years and also for his term as the Treasurer earlier. He mentioned that this would be his last meeting as the Honorary Secretary of the society. He mentioned that the last year term was during the pandemic and only 13 members could be added to the society. He informed that the names would be presented in the Treasurer Report.

He then informed that the last UAUCON 2021 at Agra in July 21 was converted from virtual to a hybrid meeting and was planned and executed only in the last 15 days. The first day of the conference was the live meeting and the 2nd day were virtual presentations transmitted in the hall and also over the zoom and YouTube platform.

He also mentioned that a lot of virtual online academic and executive meetings were held for the members during the last year to keep the members busy and updated. A total of 6 academic and journal club meetings were held with the involvement and decision of the executive committee members. He then detailed on the topics and details of the programs conducted. He further informed that all the programs were available on the YouTube channel of UAU.

He sought pardon for any shortcomings that may have happened during his term and the conduct of the hybrid UAUCON.

Members were very appreciative of the work done during his term and applauded for the activities done during the COVID period.

The report was approved.

Hon Treasurer Report

Dr Pawan Jindal presented the Treasurer Report .

He thanked all the members for their active support during his term and informed that this was his last meeting as the Treasurer of the society. He informed that for the first time Urological Association of Uttar Pradesh (UAU) had 2 Annual Conferences in a single financial year 2021 -22.

He then detailed on the breakup of the total members in the society.

He informed that the bank balance of ICICI bank as on 15th March 2022 and informed that the society has only one account. He then detailed on the status of fixed deposits of the society. He informed that there was no cash balance.

He then read the names of the new members added to the society in the past year.

He then presented that finances need to be generated for automating yearly expenses of the society so as the society is in auto mode. This included primarily society running expenses (Salaries, Website, Travel, Misc.) and accounting / audit expenses. Members discussed over the matter and resolved to raise funds to meet the same.

He also sought from the members whether the corpus of the society, should be placed in Bank FD (<5.5%) SAFE OR Debt Instruments (8-12%) Moderately SAFE over Long Term OR RBI Bonds 7.1% SAFE . Members discussed over the matter and resolved to continue with the fixed deposits in the bank.

He then presented the audited accounts of the society for the past year and then presented the income and expenditure account for the last year. He informed that the actual surplus during the FY was over 3 lakhs as identified by the auditors. However, as GST was paid from the account the net deficit in the books was 1.22 lakhs during the year. The interest component of late GST deposited would be taken up in this financial year. Members raised the queries and Dr Sanwal and Dr Jindal clarified the same. Members discussed over the matter and asked him to take the matter very carefully.

He then presented the reports for the Agra hybrid conference which was conducted by the Agra Urology Association. He presented the sponsorships received and to be received and the expenses for the meeting with a tentative surplus of around 1 lakh which will be shared with the society.

He further informed that best paper, best video, and best poster sessions were being conducted in the names as Bareilly Best Paper, Meerut Best Video and Varan asi Best Poster since their annual conferences based on their corpus for the respective best presentations. He asked the GBM whether it should be limited for a definite number of years. Members discussed over the same.

He also mentioned that after the GST is introduced and the PAN and GST of UAU is being used for the conferences, monthly returns must be filed. Considering the past 2 to 3 years he mentioned it has been difficult to obtain the same and heavy interest on the balance GST amounts had been paid in the past. He was worried if GST may issue notice regarding the aforesaid cases in coming years. He urged the future organizers to provide the bank statements and bills of services every month if they were using the UAU PAN and GST number for the event so that proper timely returns may be filed.

He also mentioned that income tax queries through AIR till 2023 may arise due to TDS deductions in earlier conferences by sponsors.

Further it was discussed, due to the practical problems, whether UAU or local urology society PAN and GST should be used. Members were of the opinion that communication should not be a problem in today's world. Members discussed in detail on the matter regarding accountability of organizers and UAU and timely return filing of UAU. Members discussed over the matter and resolved to sort out the same with the help of the auditor of the society. Dr Subhash Yadav very aggressively suggested to expand the system keeping a GST consultant and an accountant being proactive for handling the accounts. Dr Neeraj wanted the GBM to clearly resolve to what penalty should be levied in case the organizers do not timely comply. Members opined and gave their opinions. Resolved to improve the existing system rather than allowing them to use the local PAN. GB resolved and directed Dr Anurag Yadav and his new team to sort out the issues within a span of 3 months and improve the system so that this problem does not arise again.

Venue for UAUCON 2023

Dr Sanjay Garg and Pawan Kesarvani from the organising team presented the update on the preparations of UAUCON 24. The dates of the conference would be 25 and 26 March 2023. The venue they informed was Hotel Radisson Blu Kaushambi. Other arrangements were also being made promptly. The venue was very close to Delhi border and very approachable. The local organizers welcomed all the members to register early and attend in large numbers.

Members were very appreciative of the venue and promised to attend in large numbers.

Bids for UAUCON 2024

Dr Neeraj Agarwal informed that Dr H S Pahwa from Lucknow had bid for UAUCON 2024. Dr Pahwa informed the GB of all the facilities available at Lucknow and the probable venue for the same.

Members agreed and approved the same.




